1. On [REDACTED], the Investigations Division of the Office of Internal Oversight Services (ID/OIOS) received a report from [REDACTED] of [REDACTED] of sexual exploitation against [REDACTED].

2. Specifically, it was alleged that, on [REDACTED] seated in [REDACTED]. The [REDACTED] allegedly claimed that [REDACTED] had failed to [REDACTED] for sexual services rendered. The attending [REDACTED] contacted [REDACTED], who visited the scene and conducted preliminary inquiries.

3. ID/OIOS subsequently conducted an investigation into the allegations, which included interviews with [REDACTED] and the review and analysis of relevant documents and reports. However, ID/OIOS did not interview [REDACTED] as [REDACTED] left [REDACTED] prior to being interviewed. Likewise, ID/OIOS did not interview [REDACTED], who, despite extensive inquiries, could not be located.

Interview of Witnesses

4. ID/OIOS interviewed [REDACTED] who first reported the incident [REDACTED]. [REDACTED] told investigators that on the [REDACTED] in question [REDACTED] was [REDACTED] in the company of [REDACTED] and [REDACTED]. [REDACTED] when they observed [REDACTED] in a manner that suggested it had been involved in [REDACTED] said [REDACTED] and [REDACTED] approached the [REDACTED] and found [REDACTED] in the [REDACTED] and a [REDACTED] dressed [REDACTED] in the [REDACTED] appeared to be of [REDACTED] age and whilst they could not understand [REDACTED] [REDACTED] indicated that [REDACTED] had been "touched" by [REDACTED] told [REDACTED] that the [REDACTED] had entered the [REDACTED] as [REDACTED] slowed whilst [REDACTED].

down the [REDACTED] and that [REDACTED] did the [REDACTED] and requested the attendance of [REDACTED]. [REDACTED] corroborated the account of [REDACTED] did not alight from [REDACTED] and was unable to provide any additional detail.

5. [REDACTED], told ID/OIOS that [REDACTED] attended the scene of the incident following a [REDACTED] from [REDACTED] said [REDACTED] spoke to [REDACTED] who initially insisted that [REDACTED] had refused to [REDACTED] for [REDACTED] sex [REDACTED] allegedly performed [REDACTED]. [REDACTED] said that [REDACTED] then changed [REDACTED] and admitted that [REDACTED] had not engaged in sexual conduct with [REDACTED] and had made the allegation in order to obtain [REDACTED]. [REDACTED] told ID/OIOS that [REDACTED] admitted that [REDACTED] had stopped [REDACTED] with the intention of [REDACTED] for sex. [REDACTED] that as [REDACTED] started to get into [REDACTED] the reality of what [REDACTED] was contemplating dawned upon [REDACTED], and [REDACTED] immediately changed [REDACTED] mind. [REDACTED] at this time [REDACTED] began [REDACTED], demanded [REDACTED] and refused to get out of [REDACTED].

Review of Records

6. ID/OIOS reviewed both [REDACTED]s prepared at the time of the incident. The statements are generally consistent with the information provided to ID/OIOS investigators. ID/OIOS also reviewed [REDACTED], which was found to contain an undertaking signed by [REDACTED] to abide by all UN and [REDACTED] exploitation and abuse policies.

Evidence of [REDACTED]

7. According to statements made [REDACTED] that [REDACTED] had no sexual contact with [REDACTED] and had refused to leave [REDACTED] in an apparent attempt to extort [REDACTED] from [REDACTED].

Evidence of Subject

8. Based on the interview conducted by [REDACTED] on [REDACTED] [REDACTED] admitted stopping [REDACTED] to procure a [REDACTED]. However, even though [REDACTED] entered [REDACTED] quickly changed [REDACTED] and decided not to engage [REDACTED]. When [REDACTED] requested [REDACTED] to leave, [REDACTED] refused and demanded [REDACTED] from [REDACTED].

Conclusions and Recommendations

9. ID/OIOS established that [REDACTED] did have [REDACTED], [REDACTED], in [REDACTED] on the [REDACTED] of the incident. However, there was no evidence that [REDACTED] had [REDACTED] in the [REDACTED], nor was there sufficient evidence to find that the subject had consented to [REDACTED] entering this [REDACTED]. Accordingly, ID/OIOS concludes that there is insufficient evidence to find that [REDACTED] had an unauthorized [REDACTED] in [REDACTED] within the meaning of [REDACTED].

10. ID/OIOS established that [REDACTED] with the intention of procuring the services of a [REDACTED]. However, [REDACTED] maintains that [REDACTED] changed [REDACTED] mind, although not in time to prevent [REDACTED] from entering [REDACTED]. [REDACTED] told [REDACTED] that although [REDACTED] had no sexual contact with [REDACTED] attempted to [REDACTED] from [REDACTED]. Accordingly, the allegations of sexual exploitation are also unsubstantiated.

11. ID/OIOS recommends that a copy of this report be provided to the [REDACTED] to inform them of the circumstances of the case and that the allegation of sexual exploitation against [REDACTED] is unsubstantiated. [REDACTED]
